# Charities Receive Big Funding Boost

A funding lifeline of at least £50 million to support hundreds of vital Voluntary and Community Sector (VCS) projects and services was announced in October by the Big Lottery Fund (BIG).

The full impact on the VCS of cutbacks is still to come according to the National Council for Voluntary Organisations which estimates that voluntary and community groups will face a reduction in public funding of over  $\pm 900$  million by 2016, losing a total of  $\pm 2.8$  billion in that period.

Demand for services is expected to increase and BIG is planning its £50million cash injection in response to be awarded before the end of the financial year, bolstering the Sector as it deals with the developing impact of funding cuts.

As part of the package, BIG has increased funding through their existing Reaching Communities and Awards for All programmes, making an extra 650 awards, and in the coming weeks will be offering grants of up to £10,000 to around 1,000 eligible BIG grant holders who have received more than 12 months funding from us and are in the last 18 months of their project. These grants will



allow projects to review the way they work and explore ways of becoming more sustainable.

Projects coming to the end of their grant that are having a particularly significant impact will also be eligible to apply for an additional year's worth of funding to continue their project and carry out plans to make their projects more sustainable in the long term.

All eligible grant holders will be sent an e-mail from BIG about applying to the Supporting Change and Impact fund with details of how they can apply.

# **Voluntary Sector Leading Through Change**

This year SCVO's Conference and AGM provided a chance for representatives of the voluntary sector in Sandwell to make its collective voice heard and to take a leadership role locally.

Over 60 delegates from both the Voluntary and Community Sector and Public Sector in Sandwell joined SCVO's AGM and Conference which was kicked off by Mark Davis, Chief Executive Officer, providing an overview of some of the challenges affecting the voluntary sector in Sandwell. These include: public sector funding cuts; changes in funding priorities and concerns around increased competition over the funding that is available.

SCVO is helping the Sector respond to these challenges by providing networks and forums to enable them to have a voice and influence local decisions. These fora were highlighted by Leona Bird, Network Development Officer, and include a Health and Social Care Forum and a new Children and Young People Forum (see page 14 for more information). SCVO are also exploring future engagement around Housing and have begun conversations around Crime and Disorder. (please see page 13 for more information).

Steve Baylis, Funding Officer at SCVO provided details of the support available to organisations to help make them more financially sustainable. This support includes training around various aspects of completing a successful funding

application; a bi-weekly funding digest; the Funding Buddies programme which matches volunteers with organisations to provide them with funding support and a dedicated funding portal http://funding.scvo.info/. It was highlighted that SCVO has successfully assisted organisations to access over £700,000 in funding since April this year.

The AGM business then took place. SCVO's Annual Report and Annual Accounts were accepted and Ruth Levesley from Relate, Pauline Tomlinson from West Bromwich and District YMCA and Sudhakar Naidu from the Balaji Temple were all voted onto the Board. Various Board Members were stepping down including Emma Chetcuti, Tonia Flannagan, Mohammed Loan and Andrew Sjurseth and they were all thanked for their support of SCVO throughout the year.

through Change began with Nick Beddow, Chief Executive of **Community Development Exchange** providing a unique presentation and his take on the importance of leadership for the voluntary sector. The key messages were that leadership is not about being the boss. It's about collective leadership through shared vision and pooled talents. Change is not just willed from above - it happens as the outcome of forces struggling. Leadership also isn't about having power over others, or managing them towards something. It is about facilitating people to find their own answers and responses to their own needs.

SCVO's local response to leadership has been the creation of the Voluntary Sector's Leaders Forum. The Forum's aim is to provide an opportunity for the sector's Leaders to meet together and agree sector-wide approaches to common issues. The Forum also has the ability to escalate issues

#### TRANSFORMING LOCAL INFRASTRUCTURE: UPDATE

Since August, SCVO has been involved in the process of pulling together a bid to the Cabinet Office for money to improve efficiency and service offer of local voluntary sector infrastructure.

A joint bid has now been submitted, involving SCIPS, Sandwell Volunteer Centre, the Sandwell Consortium, the Community Hubs Cooperative and other partners, to establish a joint contract management centre for Sandwell's VCS. This will allow the partners to continue the collaboration and capacity building work which has been piloted over the last few years in the Borough, as well as offering enhanced local support, communication, volunteer development and linkages with business.

The bid has passed the first stage, and we will be informed in the New Year as to whether we have been successful in bringing this funding to Sandwell. At that point, there will be a number of opportunities for a wide variety of Sandwell-based organisations to input into the further development of the project. # Leaders' Survey Results

Local voluntary and community organisations continue to prove resilient in the face of increased demands and against a backdrop of diminishing funds, reveals a new SCVO report on Sandwell's VCS.

The report, compiled using data from SCVO's Voluntary Sector Directory and drawing on feedback from it's recent VCS Leaders Survey, also reveals the Sector's own 'squeezed middle'. Whilst smaller community groups and larger organisations have managed relatively well in the last 12 months, leaders of mediumsized organisations report that the cuts are hitting them hardest. This part of the Sector is also least positive about its engagement with the local public sector and is notably less optimistic than the rest of the Sector about the future.

SCVO's Chief Executive Officer Mark Davis said "Thanks to the many local leaders who completed this Survey. These findings will prove invaluable in helping us to focus our support and understand where our lobbying on behalf of the Sector can make the greatest difference."

# New £80m Of Grants Puts Community First

The Community Development Foundation (CDF) has been chosen by the Government to deliver its national Community First programme.

A small grants scheme will distribute £30m to some of the most deprived areas of the country over the next four years, and a national £50m Endowment fund will be established to sustain neighbourhood projects in the long-term. In addition, CDF will bring together partners to boost the fund by up to £10m by 2015.

The programme will support communities to enable them to make the changes they want to see in their area. In total, just over one million pounds has been allocated to sixteen wards across Sandwell, to provide money for community-led projects.

All Community First funding must be matched by community groups in the form of money, in kind contributions and the giving of volunteer time. The money will be administered by local panels supported by Panel Partners and trained Community Organisers. In some areas practical and financial help, which may be used as a match, has been pledged by the Asda Foundation.

# **Co-operation Can Secure Futures**

Ten community centres in Sandwell have collaborated to help secure their futures as Sandwell Community Hubs Cooperative.

The centres have always shared a history of collaborative working but decided to formalise their relationship to prepare themselves for changes to the funding climate. The move will enable them to work together and collaboratively bid for contracts to provide services from their respective centres.

The centres were encouraged to collaborate by commissioners at Sandwell MBC in order to provide the best chance of competing in an open tender processes. Crucially the co-operative seized the opportunity to create a future together and avoid direct competition and fragmentation of services. Tonia Flannagan said: "As community centres it's vital that we work together to win contracts and continue to offer excellent services to our users. The launch of the Sandwell Community Hubs Co-operative will do this."

# Health & Social Care Consortium Update

SCVO are committed to providing the Sector with news on progress towards the development of Sandwell Health and Social Care Consortium.

The consortium now has a Working Group consisting of fifteen organisations and held their first meeting in October 2011.

At the meeting Sharon Liggins, Sandwell PCT provided a helpful update on the development of Clinical Commissioning Groups and SCVO prepared a Collaborative Working Understanding for consultation. The main outcome from the first meeting was to quickly establish a Task and Finish

2012. The Group meets again in November to discuss adopting a parallel development process. This process will allow bidding for contracts to take place, e.g. under a lead agency agreement, whilst the Consortium moves towards establishing its independence through a special purpose vehicle.

# **Localism Bill Becomes Act** of Parliament

Just before this newsletter went to press. it was announced that the muchdiscussed Localism Bill has now received Roval Assent and has become an Act of Parliament.

However, there is still some lack of clarity about how the provisions in the Act will impact locally. The passing of the Act does not mean that all of its contents will come into force immediately, as some of its provisions will need further legislation and guidance to set out how they will work in practice.

The Department of Communities and Local Government has suggested that many of them will be in place by April 2012. but we will monitor the situation and keep you posted as to when we can expect the community provisions to be implemented.

### **Right to Challenge**

The Act as passed into law still includes the "community right to challenge" - a right for local communities and organisations to express an interest in running a Council service which they think they could run better. A "challenge" under this provision will trigger a procurement process, under which the community or group making the challenge would be able to bid however this does not take into account whether they have the capacity to either bid or to deliver the service.

### **Right to Bid**

It also includes the "community right to bid", which obliges local authorities to maintain a register of "assets of community value". When such assets come up for sale or a lease is due for surrender, communities will have a short window in which to express an interest in it, and then there will be a moratorium period on the sale or let of that asset, to allow the community an opportunity to prepare a bid. In the course of the consultation and Parliamentary debates, this moratorium period was shortened to three months. Also, we will need to see what types of assets are included in the definition "assets of community value", and how it will impact on local organisations and institutions who have allowed community use of their buildings or other assets but who might now see their ownership challenged by that very community.

# **Sector Supports Community Development**

**The Voluntary Sector in** Sandwell is being invited to get involved in the progression of Community **Development to benefit** communities across the borough's six towns.

In July 2010 the Council's Partnership and External Scrutiny Panel decided to review how the Council and its partners were working together to support and develop communities in Sandwell.

The Panel wanted to know how Community Development work was being utilised to ensure effective community consultation. engagement and involvement, and the development of social capital.

The panel acknowledged the wide variety and amount of community work happening in Sandwell;

however the approach and outcomes varied widely.

The panel were keen to ensure wider partnership working across all the relevant agencies in developing, delivering and embedding community development as this can be the key to making a real difference to communities within Sandwell.

Since then a range of partners from the statutory and voluntary sector have been working together to help respond to recommendations from the panel.

Through this partnership approach five Pathfinder organisations have been identified and are taking a leading role in developing this initiative. It is an aspiration that through strong partnership work they will develop a model

# **Priorities for Sandwell Health Board Chosen**

In October, SCVO and **Sandwell Primary Care Trust** (PCT) jointly ran a session to identify the key health and social care priorities for **Sandwell's Joint Strategic Needs Assessment (or JSNA).** 

The JSNA is an annual programme of needs assessments for individual health conditions, medical processes or issues affecting particular population groups, which should inform the service commissioning decisions made by the Health and Well Being Board and the PCT/

In an interactive session, the 19 shortlisted possible JSNA priorities were presented by Carl Griffin, the PCT's Public Health Consultant, and representatives of voluntary sector organisations from across Sandwell voted to indicate what their main priorities were. The top four priorities eventually chosen by the voluntary sector representatives were: cancer (post diagnosis and post treatment care); use of A&E (urgent care); dementia; and reducing avoidable hospital

of excellence which will have a strategic significance and impact upon community development.

The five partners are: Sandwell MBC, Sandwell Homes, Sandwell Community Hubs Co-Operative, Murray Hall Trust and Sandwell PCT. They are keen to ensure a wider involvement from the Community and Voluntary Sector.

With the support of the panel the Pathfinder organisations are supporting the development of a fully integrated Community Development Strategy, which will have a major underpinning effect on public services.

The process will be repeated annually, and in future SCVO will be represented on the JSNA Project Sub-Group which will have an input into setting out future draft priorities, so the voluntary sector will be involved from the outset.

# **Finding A Way Forward for Young People & Volunteering**

Sandwell has a thriving **Voluntary and Community** Sector with approximately 800 recognised groups across the borough; of those groups around 500 are wholly reliant on volunteers.

In response to local need, Volunteer Centre Sandwell is working with partners from private, public and Voluntary and Community Sector to develop a series of volunteering opportunities in getting the best out of our young people. Jean Taylor Chief Executive Officer comments "we have seen a significant rise in the number of young people seeking volunteering opportunities. In fact over the period 1st April 2010 to 31st March 2011 the number of people who used our services increased by 91%."

Local solutions to help young people could be developed through an expansion of accredited programmes of informal learning and volunteering. These should be included in the definition of meaningful activities. If local partners ensured that opportunities become more attractive by placing more weight on volunteering and community service as a route into work and formal training, developing local initiatives for young people who give their time can provide a wide range of social outcomes.

Young people are motivated to volunteer for a number of reasons: their personal feelings (e.g. satisfaction, feel-good); personal needs(e.g. pastime, relationships);

altruism; experience (e.g. skills and work prospects); and personal incentive (e.g. qualifications) For young people who are not engaged in education, employment or training, or who are not engaged as carers, volunteering offers a tool to help them re-engage and often has a positive impact.

Volunteering helps to develops skills which young people can then use. This includes generic skills such as teamwork, communication and other social and interpersonal

This month it's the turn of one of Sandwell's many local umbrella bodies, the Great **Bridge Community Forum, to** stand under the spotlight. **'SCVO.INFO'** talks to Maureen Whitehouse, Chair, and Linda **Paskin, Secretary of the** Forum.

#### **1.** Tell us what you do?

The Forum provides activities for the community. We're here for you from birth until you pop your clogs.

Farley Lodge is home to a number of groups including tenants and residents group, a mental health group, a youth club, a bingo club and aerobics, extend and tai'chi groups.

All the groups using the centre benefit from the support of a full time Development Officer who assists them to identify and secure funding to sustain their work and provide occasional seasonal events like a Halloween disco and a Christmas grotto and disco.

#### 2. What is your proudest achievement?

SCVO

Winning the first lottery bid of £198,000 to kick-start the forum, has to be our proudest moment,

Our relationship with Sandwell Children's Trust has enabled us to provide a youth club for five years. Unfortunately it is surviving by the skin of its teeth and desperately needs new money next year. Twelve young people achieved national qualifications last year. Three of them are CRB checked and ready to deliver sports and drama activities on the summer play scheme. Another three are being coached towards the regional table tennis team.

To contribute to the local economy the Community Forum utilises local businesses to buy services and employs local people to deliver services. In the interests of career development all staff are trained.

#### 3. What is the most valuable lesson you have learnt about working with people in Sandwell?

How do you pluck one thing from a lifetime? The most important thing is to recognise that people are unique and we should never make assumptions about anyone. Always be prepared to be surprised but remain unshockable!

#### 4. What are the plans for the future?

At the moment we're struggling

to maintain things the way they are but given the resources we would like to employ more workers to train young people for employment, develop projects to improve life for the elderly and support volunteers.

#### 5. What are the most important challenges for the voluntary sector in Sandwell in the coming years?

We must respond to the needs of the moment which are activities that bring young people closer to employment and support for parents to enable them to manage work and family life. More money needs to go direct to the grass roots to support practical work instead of being cascaded through several layers before reaching the target; marginalised and deprived communities. Stop wasting scarce resources on posh PR.

#### 6. How can SCVO help strengthen the sector over the coming years?

We need stronger communication, to be able to put a face to a name. A visit means more than a thousand emails. SCVO must bring money into the Borough and lobby on behalf of grass roots groups to stop the cascade system of funding and make sure that the voice of the little people is heard.

#### **GET INVOLVED**

- Receiving issues from the VCS and raising them with the appropriate public body

# **Sector Strives to Make Sandwell Safer**

On the 8 November 2011, SCVO, together with Safer Sandwell Partnership (the Community Safety **Partnership for Sandwell) met** with a range of voluntary and community organisations to kick start more open dialogue on services around crime and disorder.

Sector organisations providing these kind of services met with statutory partners including Sandwell MBC, the Police, the Probation Service and the Fire Service.

Over 60 delegates attending this energetic and lively event heard more about Safer Sandwell Partnership, including its main priorities of: reducing crime; increasing community cohesion; preventing and reducing reoffending; reducing harm caused by alcohol and drugs; helping people to feel safe and reducing anti-social behaviour.

Organisations were given the opportunity to provide details of the services and activities they are delivering that are contributing to these priorities, together with helping to identify gaps in areas where they feel

# New Forum Engages Children and Young People Issues

# 'Friends and Neighbours' Support Residents

The focus of social work and adult social care in the UK is changing and in response a new initiative is growing in Sandwell to harness the support of friends and neighbours for those more vulnerable within our communities.

The increase in life expectancy, growing numbers of older people and adults with disabilities living at home, decreasing size of households with more people living alone, the mobility of younger generations in search of work, career development, advances in medicine in tackling life threatening illnesses; all these factors have led to an ever increasing population of older people or people with disabilities, needing care and support.

The starting point of a new initiative called "Friends & Neighbours" is the perspective of a vulnerable resident or their carers: when someone's ill, or has a disability, when there are problems the family can't sort out themselves, residents are clear that the people they most turn to for help are their "friends and neighbours". Residents struggle to find their way through the maze of local services, who provides what, and under what circumstances. Residents trusted friends or neighbours to help or at least to find out answers.

Since 2010 a small team have been working with residents in one ward of Sandwell to show how "Friends & Neighbours" can increase the "social capital" which results from informal exchanges

and interactions between residents. The work starts from an "asset based" approach , which means quite simply that instead of viewing residents as "problems", communities and residents are seen as being rich in talents and abilities. Working from an asset based approach enthuses and energises everyone involved, because participants are working towards solutions and opportunities, rather than dwelling on obstacles.

"Friends & Neighbours" has developed a local community run organisation, which will broker support for vulnerable residents. Unlike many approaches to health and social care, the vulnerable residents are the direct clients, who decide what services they need and how they can best be supported. The Community Development Officer is working with residents to create a pool of "good neighbour" volunteers and care workers. Vulnerable residents have the offer of a visit to assess their support needs. The assessment asks residents



to think more widely about what would help improve their quality of life, and looks at options which include collective as well as individual solutions. The solutions are designed to add to existing help, if that's what residents want, and make the links with other organisations, where they are best placed to help.

More than 50 local people have already offered their services as volunteers and good neighbours. 24 local residents with related skills want to provide more in depth care and support for their "neighbours" as personal assistants.

For vulnerable residents local brokerage widens the scope of the help they can get, but at the same time, because it harnesses both informal and formal support, it liberates resources currently spent on care support. Those resources liberated are being shared between the residents, the community (through the community interest company) and the local authority.

# **December Charities Update**

### Investment Guidance For Charities

The Charity Commission recently published a new guide entitled Charities and Investment Matters.

This online guidance, which replaces the Commission's previous advice on investments, describes the legal duties and principles that apply to charity investments and the risks that trustees must address.

The guide offers a clear framework for decision making and confirms that trustees can invest ethically, sustainably, for a financial return or to achieve charitable aims or for a mix of all or any of these. But it stresses that trustees must be clear about their motive in making an investment and must justify that they are using their charity's resources in its best interests.

The guide forms part of a wider review of the Commission's financial guidance to charities, which began in 2008 in response to the economic downturn. A copy of the guidance can be downloaded from Charity Commission website.

# Umbrella Bodies Promoted

At the Charity Commission's Annual Public Meeting, Commission chair Dame Suzi Leather said that in light of the significant cuts to the Commission's budget, in the future it would expect charities to become members of umbrella bodies, which could take an advice role.

The comment prompted an unexpected flurry of criticism from charities and umbrella bodies alike.

Eager to offer reassurance Dame Suzi said "We have absolutely no intention of asking umbrella bodies to 'regulate' their members. We have no plans to pass on those core duties or responsibilities to others. However, we do know that networks and infrastructure bodies can make an important contribution by encouraging high standards and providing advice that helps prevent problems occurring in the first place."

### New Media Licensing Guide

A Beginner's Guide to Media Licensing in the Charity Sector, sets out to answer some of the questions communications professionals ask when working out where their charity stands regarding media licensing and their media monitoring work.

It covers the requirements of the Newspaper Licensing Authority and Copyright Licensing Authority and is part of a CharityComms campaign to relieve the burden of media licensing for charities. For more information visit <u>charitycomms.org.uk</u>

# **Free IT Support Project for Charities**

iT4 Communities is a project which offers a wide range of IT support including building websites, developing databases to manage information, creating IT strategies, and checking if IT equipment needs replacing.

iT4Communities matches IT professionals who want to volunteer their time and technical skills to organisations that need IT help. They have over 7,500 IT professionals across the UK who are willing to give their time to charities, community groups and social enterprises.

On average organisations get £3,000 worth of support from their volunteers. That support can be strategic advice, practical work, training or troubleshooting. Their volunteers have helped plan databases, build websites, network computers, write policies, and maintain computers.

To remain sustainable iT4 Communities charge an £85 (plus VAT) admin fee which buys 12 months advice and support from volunteers and their staff team.

and improve their contacts database, and train their staff in how to use the program effectively.

BCT is an arts charity that bring professional touring theatre and dance to local communities. They were using a database to manage contact information but it was in a poor state, containing duplicate and conflicting information. iT4Communities' volunteer, Tim O'Mara, was selected by the charity to work on this project. His expertise in databases allowed him to analyse their needs and then advise on how best to revise the structure of the database. The changes were mainly implemented



because they would not know what it involved.

Charities touch millions of people every day and achieve so much good in our communities. Trustees are the driving force behind them and are responsible for making decisions about a charity's direction and activity.

As well as being of huge benefit to the charity, trusteeship provides

within six months, but Tim continued to support BCT as they tested the revised system. He then provided training to staff members showing them how to edit data and how to extract information.
