# An Exciting Expansion to SCVO's Buddies Programme

SCVO has recently been awarded funding through the Social Action Fund to expand its highly regarded business and funding buddies pilot projects. We are looking to recruit volunteer buddies and voluntary and community sector organisations to host a buddy to offer support in funding, business, finance or marketing/media.

Over the next 20 months SCVO will be working initially across Sandwell and then expand into our neighbouring Black Country boroughs to recruit volunteers. We are looking for individuals who have expertise and experience in Funding, Media/Marketing, Business and Finance. Two areas of particular focus will be undergraduates and newly retired individuals. We will work with public sector, business sector, higher education institutions and the Voluntary and Community Sector (VCS). SCVO will provide support for volunteers to apply their workbased skills in placements with host small and medium sized voluntary and community sector organisations. VCS organisations can apply to host a buddy to work with them in one or more of the areas mentioned above. SCVO will be working closely with Sandwell Volunteers and other volunteer agencies and infrastructure organisations across the Black Country. SCVO will be employing two full-time members of staff and a part-time administrator to lead on the project which will add to the Capacity Building Team.

# **Tribute to Liz Mabley**

One of the most recognised. well known and best loved community figures in Sandwell sadly passed away in early December 2011.

Liz began work in Sandwell in 1971 as a teacher at Devonshire Rd primary, moving on to Corbett St School in Smethwick in 1972. In 1974 she moved to the home school links team, putting community development at the heart of her work.

From there Liz went on to be a founder member of the Community Links team and played an important role in Tipton City Challenge, the Lottery Fair Share programme and a range of other major regeneration schemes. As a reward for her hard work and commitment as an active champion for community development, she was awarded an MBE in 2001.

From 2002 Liz began to work very closely with Gary Bowman (pictured with Liz, right) to establish Sandwell Partnership,



building strong community networks across Sandwell. Local people and community organisations remained at the heart of Liz's work and she won enormous respect and warmth from them.

Liz was a much loved, larger than life woman - elegant, warm, with an instantly recognisable laugh, who always made room in her life for other people.

She will be greatly missed.

# Leaders' Forum Update

In November, the Voluntary and **Community Sector Leaders'** Forum, a group of senior voluntary sector managers convened by SCVO, met with Kerry Bolister, who was appointed in the summer of **2011 as Sandwell Metropolitan Borough Council's Area Director for Homes and Communities.** 

Kerry gave the Forum an introduction to her role, which encompasses housing in all its facets, and functions around community development and community safety, and gave a few pointers as to how voluntary and

community sector providers could engage with her and her staff. In particular, she was keen to set up an opportunity for voluntary and community sector provider organisations to meet with the contractors who are delivering the newbuild housing in the Borough, to explore the potential for the sector to provide services to tenants on the new developments which are currently being built, as well as a specific event to discuss allocation of Section 106 funding. # New plan for Sandwell's Libraries

# National Policy Update **Public Health Transition**

**Sandwell Primary Care Trust** is making progress on the transition of public health to Sandwell Metropolitan Borough Council (SMBC).

To oversee the process, a Steering Group consisting of Directors from both Sandwell Primary Care Trust and SMBC, has been established. A Project Board will project manage the transition process and Sandwell PCT have been working on the transition plan and a first draft of this has been submitted to the Strategic Health Authority. The final plan must be completed by March 2012.

Over the next year Sandwell PCT will undertake work, as part of the development of the Health and Wellbeing Board strategy and priorities, to develop proposed commissioning plans for the future and establishing recommendations for commissioning post April 2013. They will agree these plans through Council processes as part of the Council business planning and

budgetary cycle and will undertake procurement during 2012/13 jointly, to ensure continuity of service in 2013.

In the mean time all public health contracts have been mapped onto a detailed database and compared this with the mapped budget as above, to ensure its completeness and accuracy. Sandwell PCT have identified the contracts that were due to expire in March 2012 in order to establish immediate actions to ensure maintenance of the public health system throughout this transition year. While ensuring that the number of commitments beyond that date are minimised to allow for the commissioning strategy and plans to be agreed through Council processes and in line with the Health and Wellbeing Board priorities.

The following three headline areas of action have been agreed to ensure smooth transition of the arrangements:-

# Localism Act Update

After much debate and speculation, and many changes during its passage through **Parliament, the Localism Act** 2011 is now in force.

Many of its provisions are now due to come into force in April 2012, including:

• the "Right to Challenge" (the ability for community groups to challenge inadequate delivery of services by public sector providers and their contractors, to express an interest in delivering those services

- themselves, and to instigate a procurement process for those services);
- for communities to instigate developments that they feel are required in their local area - for example shops, playgrounds, new schools)
- local assets with community value (which will require Councils to compile a list of assets of community value in each authority area):
- the power to put in place





- Undertaking work to extend contracts for 2012/13 where required and within PCT financial instructions
- Identifying the contracts for transfer and progress the arrangements to ensure these are innovated to the Council by April 2013
- Agreeing through the processes, as described above, plans for future services commissioning and using Sandwell MBC procurement processes to establish these from April 2013. A member of public health/PCT contract staff will be seconded to support this process in the Council to ensure continuity.

• the "Right to Build" (a power a "Community Right to Bid" for "neighbourhood plans" for a local area.

These, among other provisions in the Bill, could be very significant for the voluntary sector in Sandwell. SCVO has linked up with the Chamberlain Forum to organise a briefing event, to answer some of the questions which are raised by the legislation. # **Important: Update your Profile Settings on** finditinsandwell

Are you a registered user on findit? Have you stopped receiving emails about the latest news and contracting opportunities from the findit team?

The findit team sent an email to remind everyone about the change to sectors. It's a good idea to check your spam or junk mail folder for info on the change. You should also check your profile settings, especially if you've stopped receiving update emails from findit.

Follow the steps below to make sure you get the latest news:

- 1. Visit www.finditinsandwelll. co.uk.
- 2. Login to findit using your email and password.
- 3. Once you've logged in click through to Edit your profile on the right hand side.
- 4. On the screen that appears click the Sectors tab. Findit's sectors have been completely redesigned and now contain nearly 10,000 different subsectors. This allows users to match their opportunities more accurately. The easiest



way to select your sectors is to use the search box below the drop down window.

- 5. It's Important not to be too specific, allowing the site to find all of the relevant sectors for you, e.g. using keywords separately allows you to find more sub-sectors.
- 6. In the large box you will be asked to select sub-sectors.
- Click Save Selection after each search you perform.

You should now receive updates for your selected sectors from findit. However, to make certain you receive news, please click on the Edit details tab and make sure you do the following:

- 1. Checked the email alerts box:
- 2. Updated your mail address clicking Change email;
- 3. Click Update to save changes.

# **February Charities Update**

### **Vetting and Barring** Scheme Update

In November 2012 we are told to expect to see the Criminal Records Bureau (CRB) and the Independent Safeguarding Authority (ISA) merge to become a single public body called the **Disclosure and Barring Scheme** (DBS). This new organisation will provide a barring and criminal records disclosure service. In the meantime though it's business as usual. Safeguarding duties introduced in October 2009 continue to apply. An organisation which knowingly employs a barred person to work with children or vulnerable adults will be breaking the law. A new e-newsletter, launched in January, is designed to keep those working with children and vulnerable people informed about the progress of the Protection of Freedom Bill and the Vetting and Barring Scheme and Criminal Records Regime Reviews. ### National Insurance Holiday for Charities **Generating Income** from Trading

New businesses set up outside London, the South East and the East of England after 22June 2010 may be entitled to a holiday on employer's national insurance contributions for the first 10 employees hired during the business's first year of operation. The NICs holiday will last for the first 52 weeks of employment or until 5 September 2013. The

holiday is not an automatic right but a holiday of up to £5,000 per employee is possible for successful employers. Only new charities which have a business element are eligible. The National Insurance Contributions Act 2011, which set up the scheme, is at www. legislation.gov.uk

### **New European Directive on** Commissioning

The European Commission has published draft rules on public procurement that are expected to make it easier for charities to win public sector contracts. The proposed directive, published in December, is intended to simplify European Union commissioning laws. The directive says it will invite public bodies to break down contracts so that small organisations can bid for them. If the bodies refuse to do so they should publish an explanation. It will also aim to reduce the documentation needed by smaller organisations to bid for contracts successfully. The directive proposes that public sector commissioners should consider the social impact of organisations that bid for contracts. However, it is not clear whether this part of the directive would place additional requirements on the UK government, which is already backing the bill, introduced by Chris White, the Conservative MP for Warwick & Learnington. This would require commissioners of public sector services to consider how they might "promote or improve the economic, social or environmental wellbeing" of their local area through contract.

# **Hill Top Community Development Association**

This month Hill Top Community **Development Association** are in the spotlight. 'SCVO. INFO' talks to Carole Griffiths, **Chairperson of the Association.** 

#### 1. Tell us what you do.

The Association was established in 2010 and we are a Registered Charity. We aim to help groups using Hill Top Community Centre to obtain grants and provide a community resource that offers space to local groups to run activities from. The Centre has training rooms and office space available for groups at reduced rates and for private hire.

There's always lots going on here and regular users of the Centre include: Success Slimming Club; Zoom exercise; Karate; Sandwell Family History Group; Millennium Beat Music Group; Cruse Bereavement Care and CARES. There are also training activities running at the Centre, two lunch clubs including a service for the housebound and a Youth Club.

#### 2. What is your proudest achievement?

My proudest moment for the Association was when we launched, after helpful advice from SCVO with our constitution and setting up. I'm also proud of the formal collaborative working the Association is starting to get involved in and we recently joined

#### Sandwell Community Hubs Cooperative Ltd, which was a totally new experience for us.

#### 3. What is the most valuable lesson you have learnt about working with people in Sandwell?

The most valuable lesson I have learnt about working with people in Sandwell is recognising diversity and equality and understanding people's general outlook on life. There are many different groups of people in Sandwell all striving for the same aims in life, but mainly people need to enjoy a safe and enjoyable environment with the company of like minded people. For us this means our local youth club, luncheon club, church, slimming club, karate and striders club. People join together to enjoy the same hobbies and to meet a social need. It is our remit to enable and encourage this activity whilst supporting local groups in new initiatives.

#### 4. What are the plans for the future?

I would like to see the Centre used even more than it is now and welcome in local groups delivering new activities for Hill Top. We would also like to help the new groups apply for funding to help meet their needs. We can help the residents of Hill Top in so many ways, but if we could start to help improve literacy skills and give

people a helping hand back into work this might build confidence and strengthen the community.

#### 5. What are the most important challenges for the voluntary sector in Sandwell in the coming years?

Small organisations are finding the public sector funding cuts difficult and everyone is struggling to find resources to support the Sector. Helping local communities is what we do best so it would mean a great deal to the Sector to be in a strong position to bid for funds - alone or in collaboration with others.

#### 6. How can SCVO help strengthen the sector over the coming years?

SCVO are friendly, approachable and give out good advice. SCVO try to help people and most importantly they will physically come out to meet you, get to know your organisation and when they don't have all the answers they signpost you to places of support. The one-to-one local support that SCVO offers is so important but the Sector also needs to know more about national sources of support. Please keep sending out the information about specialist projects and support services, e.g. legal advice projects, otherwise nobody will know just how much support there is out there for the Sector.

# Prime Minister's Visit to Sandwell

**David Cameron attended** Sandwell to announce the launch of over £400 million funding to help members of England's most troubled families. The announcement was made on the 15 **December 2011 when the Prime Minister attended local** voluntary and community organisation, Krunch.

The Prime Minister highlighted the fact that the Coalition Government is keen to strengthen the social recovery of the Country as they are in strengthening the economy. At present the Government system and the services being provided are not helping those with multiple disadvantages, whether through drug addiction, crime and disruption. The services currently being provided are often disjointed and families and the issues that they are experiencing are not seen as a whole. An estimate of £9 billion is spent on around 120,000 troubled families, equating to £75,000 per year per family.

David Cameron went on to say that the State have failed these families in the past . however much work is being undertaken to improve schools, create safer streets and reform the welfare system.

The launch of this funding would be to enable a key worker to put an action plan in place to help these identified families to access services but also to enable them to start taking responsibility for

their own actions.

In Sandwell the data at present suggests that there are over 1,000 troubled families and in February the Local Authority will be asked to provide information of where these families are located. The funding provided will make up 40% with the Local Authority contributing 60%. The Prime Minister highlighted that social action as well as State action was needed to make this initiative work and payment would only be received upon result. The emphasis on the voluntary and community sector's role in supporting this social action was highlighted.

# Greets Green Gets a New Community Centre

A new Community Resource Centre in Harwood Street was officially unveiled by Lord King of West Bromwich on Wednesday 21 December.

The Centre is a partnership initiative between the Sandwell Council, Confederation of Bangladeshi Organisations and the Big Lottery Fund dedicated to providing a One-Stop-Shop facility.

This modern facility, located in the heart of the Greets Green community, will provide services and activities including a youth club, skills and vocational training, health and fitness club, conference and meeting facilities, and crèche and child care.

The launch ceremony was attended by local dignitaries, community workers and members of the public. Leader of the Council, Darren Cooper, Chief Executive of Sandwell, Jan Britton and Coucillor John Edwards addressed the attendees and spoke about how the new Centre is a vital resource for the community at a time of other service and spending cuts. Dr Mike Beazley from the University of Birmingham hailed the work of local Bangladeshi people in their on-going community-led regeneration efforts which started in 2001.

Abdul Hannan, Anam Choudhury, Shabud Ullah, and Mohammed Rohim spoke about the growth and development of their organisations, CBO and Hidden Talents Partnership, and how their hard work and perseverance has culminated in the form of this very important facility for the local community.

Lifetime Achievement Awards were handed to Councillor Gurcharan Singh Sidhu, Mr Hiron Miah, Mr Zia Chowdhury, and Mr Musleh Uddin for their long-established work and service for the people of Sandwell which included the founding of CBO in 1985.

# Awards for All Help Friends Learn Together

The Black Country may be famous for its industrial heritage but don't let that fool you. Artistic creativity can be found in equal measure, as Friends United Learning Together in Smethwick prove.

With a grant of £7,980 from Awards for All they run weekly IT based arts and crafts workshops for the older generation, offering vital support and friendship. Janet Banks is a 24 hour carer for her adult son. She suffers depression and these classes are the only break she gets from her responsibilities. She said "It's a long day on my own. That's why it's nice to get out and meet other people. It's a chance to get away from my problems and forget about it for a while."

Barbara Bright, a professional teacher who runs the classes said "the sessions give people a

chance to learn new skills and be creative, but it's more than that. They come here because they feel safe. It is their friendship, their support and often their respite. It makes a huge difference to their well-being."

# **Compact in Action**

Following the announcement of a funding opportunity, concerns were raised by a number of Voluntary and Community Sector Organisations over the timescales given to get applications submitted. SCVO raised these concerns on behalf of the Sector.

The issues related to Positive Activities for Young People funding for 2012/13 Voluntary and Community Sector organisations were given 6 weeks to apply, including the Christmas period, yet there had been 8 months lead

Organisations felt under real pressure, having to respond to tight deadlines over a holiday period. This was raised by SCVO on 5 December as a Compact issue. Sandwell Council has formally responded with an apology, explaining the reasons for the protracted discussions about the allocation of the resources, acknowledging that it would have been better if the procurement process could have started earlier in the year and that, although a

in to the start of the application process and 3 months assigned for assessment and decision making. longer deadline had been given, their actions had fallen short of the spirit of the Compact.

The Council has already begun work on the funding, service specification and procurement process for next year's awards, in order to avoid the risk of applications being rushed again. Essentially the Compact provides an opportunity for both sides to explain their point of view and try to understand the other's perspective. This helps to build stronger relationships and to learn lessons for the future.

This event will enable you to hear from both Lloyds TSB and Children in Need about their area priorities, followed up by the opportunity to have a 1:1 session to discuss your project idea.
