Funders Have More Money for Sandwell!

SCVO and Sandwell MBC's External Funding Team are working in partnership with funders to increase the amount of money coming into the borough. Key funders tell us that although they receive a fair number of applications from Sandwell, the success rate is generally low. By developing closer relationships between funders and the Sector, we are determined this can change.

Our first approach to the problem is to bring funders into the borough to increase their awareness of Sandwell and our awareness of their programmes, priorities and local contacts. Back in March, SCVO and the External Funding Team met with the Big Lottery Fund's Development Officer for the West Midlands. We learnt that while Sandwell is close to the national average for Awards for All success, it fares much worse with the Reaching Communities programme. The key pointers for success were: to address a well-evidenced need. to have clear and measurable outcomes, to show value for money and to avoid duplication with other services. This meeting was just the first in a line of meetings planned. We are currently developing relationships



with The Arts Council, Children in Need, Comic Relief and Lloyds TSB.

We are also jointly enabling closer contact between funders and the wider sector. Sandwell MBC organise funding fairs where a variety of funders are available for one to one discussions and SCVO are developing a policy of inviting funders to be present at our training courses as co-facilitators. Last year's training programme saw the participation of Children in Need and the Heritage Lottery Fund and this will be replicated for our new training programme beginning in June.

Politicians Back Local VCS

SCVO recently welcomed
Sandwell MBC Leader,
Councillor Darren Cooper, to
discussions centred on the
changes at the Council and
how we can best develop
relationships with our
Voluntary and Community
Sector (VCS).

SCVO were able to raise concerns over how some of the changes were adversely affecting local organisations, and challenge Cllr Cooper on how the council can ensure, that within the current budget constraints and the move towards more open competitive tendering, investment is made to ensure a healthy locally-rooted Sector. Cllr Cooper re-iterated

the council's support for the VCS and emphasised that their commitment is demonstrated by maintaining the ring-fenced voluntary sector support budget. He welcomed increased dialogue and the important contribution and constructive challenge the Sector gives on behalf of local communities in Sandwell.

The opportunity to speak more directly to central government was also presented to SCVO by way of a meeting with James Morris, Conservative MP for Halesowen, covering Rowley Regis. Aside from his consitituency work, James has a particular interest in economic development, enterprise and how to address skills gaps and

worklessness in the borough. SCVO highlighted the important role the VCS play both as an employer and service provider, and the work they do in helping local residents move closer to the job market. Concerns were also raised on behalf of local providers over the lack of involvement of VCS partners in the Government's new Work Programme.

As James is a member of the government committee focusing on the forthcoming Localism Bill, SCVO will look to explore future opportunities to hear more from James about the Bill and what this might mean for local communities and the VCS.

Health & Social **Care - Exploring Collaborative** Working

Leaders' Forum

This is a newly created Forum which had its inaugural meeting in May 2011. The Forum meetings are bi-monthly and exist to provide an opportunity for principal voluntary sector leaders in the Sandwell area to meet and discuss sector-wide approaches to common issues and to decide what action can be taken, either by members or by SCVO on behalf of the group. Issues will be escalated to senior individuals within the public or private sectors as necessary via the Chief

Executive Officer of SCVO. Once a year, the Group will promote a major VCS Leaders' Summit, attracting as many of Sandwell's senior VCS leaders, managers and chief officers as possible, to outline the work of the group and to take a broader sounding of the issues facing the VCS locally.

National Policy Update

CHILDREN & YOUNG PEOPLE

Children's Workforce Survey

For the past few months, SCVO has been working with Sandwell MBC and the Children's Workforce Development Council to map the children's workforce in the Borough.

We are just about to refresh our data on children's organisations in Sandwell, so if you work with children, you should be receiving a survey from us, asking you a few simple questions about the staff and volunteers who deliver your service. This will help us understand the workforce in Sandwell, and offer better support and training to organisations. Please return this survey as soon as you can!

Health and Social Care Bill

It's been hard to miss the media coverage and controversy surrounding the Government's plans for the NHS and for the health and social system in general.

Since the publication of the White Paper "Equity and Excellence: liberating the NHS", Health Secretary Andrew Lansley has taken a battering from all sides about his proposed health reforms. Firstly, coalition partners the Liberal Democrats passed a strongly critical motion at their Spring Conference. Then, the British Medical Association weighed in, at an emergency meeting in March, raising concerns about the abolition of PCTs, the role of competition in the health economy, the remit of the National Commissioning Board and the powers of Healthwatch, the new body promoting patient voice. Then, the Public Accounts Select Committee took the unusual step of publishing a report on the reforms even though they were still before Parliament. The report expressed concerns that the localisation of healthcare would make it more difficult to monitor the spending of public money, and that the abolition of PCTs would mean that there would be



no "plan B" if new health bodies like GP consortia failed. Recent discussions have focussed on the extent to which the healthcare market in future will be based on competition, and whether this will lead to the privatisation of healthcare.

The Government was forced to announce a "pause" in NHS reform in early April to take stock, and embarked on a "listening exercise" to take soundings on how their planned reforms might need to be adapted. The principal change which has been mooted is that other professionals, for example nurses, may also have a commissioning role alongside the GPs. However, the process of GP consortium formation (and, in many areas, the dismantling of PCTs) is now very well advanced, so it is probable that, whatever changes are made, the GP consortia will still have a major role in commissioning. It is therefore still very important, despite some possible scaling back of the original commissioning proposal, that the VCS prepares itself for greater interaction with individual GP consortia and, in Sandwell's case, groups of consortia. And, if further competition is permitted in the health market, the VCS will need to be ready to compete with providers from other sectors. both mutuals launched by expublic sector workers, and private companies.

Although the "listening exercise" is now over, it is likely that there will be further changes to the Government' plans for healthcare. SCVO will keep you abreast of what this means for us in Sandwell.



Election Results - What do they Mean for the for the VCS?

The local elections in England were widely seen as an early referendum on the Coalition Government and its economic and social policies.

The most striking feature of the results was that the Conservative vote held up across most of the country, with a net gain of 4 councils, whilst the Liberal Democrats suffered major losses. widely seen as a punishment for their support for deficit reduction. Deficit reduction has been at the heart of the Coalition Government's policies, with the repeated refrain "we are all in this together" and the emphasis on rebalancing the country's books. This has meant changes to the funding settlement with local

authorities across the country, resulting in a number of councils facing reductions of up to 8.9% in their total funding allocation over the next two years. Commentators generally agree that any cuts in services resulting from these reductions have not bitten yet, but are likely to do so in the next 18 months.

When cuts do come, they are likely to be unevenly distributed, as different Councils have received different levels of funding reduction. Sandwell has seen a year-on-year cut between 2010-11 and 2011-12 of over 9%, but made a decision to protect the core voluntary and community sector budget in this financial

year. This does not mean that the financial pain which the Council experiences won't be passed on through lower budget allocations for commissioned services, or that such protection will still be possible next year.

The Conservatives' relatively good showing in the elections means that there is unlikely to be a change of course on economic policy – indeed, even if it had gone badly for them, they are too far advanced along the road of deficit reduction to turn back now. SCVO will keep monitoring the funding environment and stay in close contact with key individuals at the Council and PCT, to ensure that you're kept informed.

Advice and Guidance Providers Review

SMBC is conducting a review into the provision of advice and guidance services in the Borough. How do such reviews work, and what potential opportunities for the VCS do these reviews afford?

In the current financial climate, public authorities are taking the opportunity to look again at the way in which services are delivered. In Sandwell a review of advice and guidance services is underway. It includes specialist advice providers, such as the Citizens Advice Bureau, alongside other social and welfare services, such as the Bangladeshi Islamic Centre (see Spotlight Interview). The aim of the review is to make advice and guidance across Sandwell more strategic,

limiting the "carrier-bag-of-leaflets syndrome" of clients being passed from one provider to another for different types of advice, and to make the provision of advice more focussed on outcomes.

SCVO has convened two meetings of advice and guidance providers across Sandwell to discuss and influence the way the review is being conducted, and to encourage greater collaboration between organisations through an Advice Providers' Network. Mapping is under way of the advice and guidance provision, with a view to implementing a new commissioning framework in 2011-12.

SCVO is working to influence both the way individual reviews are

conducted and their outcomes. and the overall process which Sandwell MBC uses to conduct such reviews. At present, there are a wide range of approaches to consultation, mapping, data analysis, performance management and engagement. Service providers have found themselves subject to a number of different reviews for different aspects of their services, or asked to respond to very fundamental reviews of their service in relatively short timescales. Voluntary sector providers need to be adaptable to changing priorities, and prepared for increased collaboration, in the current climate. SCVO will be working to make sure there is a level playing field and common process when reviews are carried out.



CHARITABLE INCORPORATED ORGANISATIONS UPDATE

The Charity Commission has published guidance and model constitutions for charitable incorporated organisations (CIOs).

However there are still no final draft regulations and no implementation date. When they do arrive these will come from the Office for Civil Society rather than the Commission.

A CIO brought in by the 2006 Charities Act, is an incorporated form of charity which is not a company. It only has to register with the Charity Commission and not Companies House.

Sam Younger, Chief Executive of the Charity Commission said; "By making the CIO guidance and constitutions available now, there is the opportunity for people to look more closely at whether the CIO structure is the right one for their needs, and what will be involved. The guidance will help ensure people are clear about what being a CIO would mean ahead of the new structure being implemented."

June Charities Update

Understanding Your Responsibilities as a Charity Trustee

The government's Big Society agenda is encouraging us all to give back to society. One of the ways to do this is to consider joining the committee or board of a local community group. In doing so you become a Trustee, which means that you accept ultimate responsibility for directing the affairs of the group, and ensuring that it is solvent, well-run, and meeting the needs for which it has been set up. Anyone taking up the role should know what legal duties, responsibilities and potential liabilities are involved. Updated Guidance on Insurance

The law requires charities to have certain types of insurance and the decision to buy additional insurance is one way that charity trustees can carry out their duty to protect their charity's trustees, assets and resources. Updated guidance from the Charity Commission clarifies what legal obligations there are in connection with insurance and helps trustees decide when and what insurance will be appropriate for their charity. Cheques Set to be Phased out in 2018

Cheques are set to be phased out in 2018, with potentially devastating consequences for charities according to The Institute of Fundraising. Charities have been at the forefront of the battle to save the cheque, or at least delay the abolition. The Institute of Fundraising has told MPs that more than 70% of charity donations are made by cheque. The chief executive of the Charities Aid Foundation (CAF) bank, said that figures prove there are still huge amounts of cheques being used in the charity sector and that this represents a significant part of charitable income. He recommends that alternatives to cheques must be in place and widely used by both the public and charities, before the decision is taken to abolish them.

Vetting and Barring

The government has changed its mind about scaling back the age limit on vetting and barring arrangements for children's professionals. After consulting children's charities the government has amended the Protection of Freedom Bill to include people working with 17 year olds. Originally the cut off was going to be at 16. Andrew Flanagan, chief executive of the NSPCC said, "Young people can be particularly vulnerable to grooming and abuse from adults who work with them and wish to develop inappropriate relationships. It is important that adults working closely with these young people are subject to robust checks."

Spotlight on ... Bangladeshi Islamic Centre

This month we talk to Abdul Subhan (Centre Manager) Faruque Khan (Youth Outreach Worker) and Alamgir Khandoker (Bangladeshi Men Health Development Officer) from Bangladeshi Islamic Centre. 0121 558 8204/www.bicentre. org.uk

1. Tell us what you do.

We are a community based organisation working for and being run and led by the community, based in Smethwick, our services and activities cover all of Sandwell. We offer free, fair, impartial and confidential Information, Advice and Guidance (IAG), assisting people to make well informed and realistic decisions about benefits. Since 2007 the organisation has been registered with OISC to provide Level 1 Immigration Advice. We also run workshops on the prevention and treatment of health related problems and issues including diabetes, smoking, strokes and coronary heart disease. A major thrust of BIC's health related work has been the promotion of physical activity and encouragement of healthy lifestyles. We support local women with training, social activities and skills development. The activities break the cycle of isolation and promote social exclusion for many disadvantaged women. We have many activities taking place at the centre including pool, table tennis, board games and other

activities such as football, cricket and canoeing. We assist children with literacy and numeracy and homework support. We have a programme to encourage parents to take an active role in their children's education and development. We have an employment advisor that provides support in finding work, writing CV's and interview techniques.

2. What is your proudest achievement?

It is hard to highlight just one, however, our support to young people around education and attainment has helped many of them to graduate from Universities such as Cambridge and go on to secure professional employment as doctors and general practitioners.

3. What is the most valuable lesson you have learnt about working with people in Sandwell?

With a little support, a lot can be achieved. Small pots of funding enable activities to be provided and unlock the potential in people making a huge difference to people's lives. Awareness raising events can reach many people and working together with other organisations has helped us to promote holistic services to the communities of Sandwell.

4. What are the plans for the future?

To continue to deliver the services



we provide. We are expanding our building and also have plans to have a new building. The demand for our services is growing and we need to ensure that we expand to meet the needs. We want to work with SMBC to make Smethwick and Sandwell a better place to live and work in for its residents.

5. What are the most important challenges for the voluntary sector in Sandwell in the coming years?

Ensuring that they can deal with the demand for services, given the reductions in funding available. The changing funding environment is creating competition for organisations and the sector needs to make sure that the added value they bring is recognised. It is not necessarily the case that reinventing new things is the best way and there needs to be a focus on what is working well and building on this. We need the great support we are getting from the elected members and Local Authority to continue.

6. How can SCVO help strengthen the sector over the coming years?

Continue with networking support as this helps with the sharing of ideas. Build on the training sessions that have been provided to groups and continue to provide a voice for the sector and challenge on behalf of the sector at a local and national level.

Television is Going Digital!

The digital TV switchover is starting in Sandwell from September 2011.

Analogue TV signals will be turned off and Freeview services boosted to reach all areas. After switchover, virtually all homes will be able to receive digital TV free via an aerial, including those served by local relay transmitters. When you switch depends on which transmitter your TV gets its signal from.

To find out when you switch and what your digital options are, visit www.digitaluk.co.uk or call Digital UK on 08456 50 50 50.

What do you need to do?

- If you have Freeview, Top Up TV or BT Vision, you will need to retune your digital TV or box at switchover or you will lose channels. Switchover is a twostage process and you need to retune at both stages.
- If you have a satellite or cable service on all your sets, you will not need to retune as these are not affected by switchover.

- If you have 5 channels or fewer (i.e. analogue TV) on any of your sets, you will need to convert them to digital.
- If you're 75 and over, or eligible disabled, call the Switchover Help Scheme - they can provide everything you need to keep watching your TV.

Age Concern Birmingham can provide grants, materials, free training, support and guidance during the run-up to the digital TV switchover to organisations that support:

- older people
- people who are socially isolated
- people with sensory, mobility or dexterity impairments
- people who have mental health conditions
- people with English as a second language
- people with learning difficulties.

Grant Making Trusts and Foundations

Sita Trust, Enhancing Communities Programme

Under the Sita Trust's Enhancing Communities Programme Core Fund, grants of up to £60,000 are available to not for profit organisations, community groups, parish councils, local authorities and charities for projects that make physical improvements to community facilities and historic buildings / structures, Projects must have an overall cost of less than £250,000. SITA will accept applications from projects which are within 3 miles of qualifying SITA UK waste processing sites. Grants of up to £20,000 are also available through their Fast Track Fund for projects with an overall cost of no more than £40,000.

Projects on school or pre-school sites where the facilities will primarily benefit the school are not eligible. However, an application may be considered from a school if the following can be clearly demonstrated:

- The wider community has significant opportunities to use the facility;
- The facility is run by an organisation that is separate from the school (although the school may be represented);
- Access to the facility for community use must be via an entrance that is separate from the school.

The next closing date for applications is 20 June 2011 for the Fast Track Fund (formerly Small Grants Scheme) scheme and 25 July 2011 for the Core Fund (formerly Large Grant Scheme). Visit: www.sitatrust.org.uk/

They welcome applications from registered charities and schools working within their key priorities. Any national charity working within their key priorities that can ringfence their activities to a local community is eligible. Funding for Community, Heritage and Environmental Projects

WREN provides funding for community, heritage and environmental projects in areas close to landfill sites they award

grants for environmental, heritage and community projects and have announced the details of the deadlines for their Main Grant and Small Grant programmes for 2011. Areas have now been allocated one of four deadline dates for each funding round in May, August and November. The small grants programme provides grants between £2,000 and £15,000 with a total project cost of under £50,000. The WREN Main Grant Scheme offers funding of between £15,001 and £50,000. Eligible organisations that can apply for funding include environmental organisations. voluntary groups, charities, not-forprofit organisations and community groups. Deutsche Bank Community Development Fund

Projects must demonstrate a local community need and meet with your group's aims and objectives. The fund seeks to target projects tackling education and community development, with a specific emphasis on working with those who are NEET (Not in Employment, Education or Training). There are two grant programmes but groups can only apply for one. The programmes are as follows:-

- Grants range from £250
 minimum to £5,000 maximum.
 Grants will need to be spent
 within 6 months of receipt, or
- 2. A one off grant available of up to £15,000 maximum to be paid over 2 years i.e. £10,000 in the first year and £5,000 in the second year.

Applications are welcome from not-for-profit, third sector voluntary or community group, active in their local community for not less than 12 months. Groups must be based in the Birmingham or Black Country areas (Dudley, Sandwell, Walsall, Wolverhampton) They must be carrying out projects benefiting young people aged 11-25 in the following key areas:

- Education (Retention, Achievement and Progression)
- Community Development (Community Sport, Educational Outreach, Employment and Employability, Homelessness and Neighbourhood Renewal)

Examples of what can be funded are: projects that ease the transition between primary and secondary schools, reduce absenteeism, and help prevent exclusion and projects that raise aspirations, achievement and attainment levels, with a particular focus on financial literacy, business awareness, functional and soft skills

Partnership Update

Sandwell Compact in Action

The Compact is a set of principles setting out good practice for how the relationship between the statutory and voluntary and community sector (VCS) should operate. It is sometimes difficult for partners to see what benefits the Compact brings to these relationships. Sandwell has developed some case studies to highlight how the Compact had been used to overcome barriers and issues to the sectors working together. Here is an example case study.

What was the issue?

Connecting Communities was a short term Government funding opportunity with which Sandwell Partnership commissioned services from four medium sized voluntary organisations. Services were targeted at disaffected, hard to reach young people. A range of issues emerged linked to the administration of the funding and the financial monitoring arrangements. These were raised by one organisation with the head of the Council's Strategic Investment Unit who asked Sandwell Partnership to look into the matter.

What has been done about it?
Sandwell Partnership
talked to all of the parties
involved and produced a

report that summarised the issues and made 9 general recommendations, 3 of which were specific to the Connecting Communities programme. These recommendations have been accepted.

What outcomes were achieved? Sandwell Compact gave the framework for the VCS to air their concerns openly and this led to a commitment from the council to:

- look at their financial monitoring requirements
- rethink their position on risk in line with the Compact
- look at how they make payments to the VCS
